PATRICIA LOUISE AHRENS

Director, Northern Credit Union



Louise has a dedicated interest in the credit union business for over 40 years, having been a long-time member of the Elmwood Credit Union, Saugeen Credit Union and presently, Northern Credit Union, of which she is a member of the Board of Directors. She was keen to be a director and was elected to the Board of Saugeen Credit Union in 2011. She enjoys learning and received her Accredited Canadian Credit Union Director certification two years after joining the Board of Northern Credit Union (through merger) in 2017. She is presently serving her second term on the Board.

EARL CAMPBELL

Director, Alterna & Savings Credit Union



Earl Campbell is a past Chair of Metro Credit Union, Alterna Savings, Alterna Bank and Interim Executive Director of the Ontario Credit Union Foundation.
